## PREAMBLE

These Membership Rules and Regulations ("Rules and Regulations") are established by Apple Mountain Golf Resort ("Apple Mountain") and the Board of Directors ("the Board") of the Club at Apple Mountain ("the Club") to protect the facilities and to promote the health, safety, welfare and enjoyment of the members, their families and guests and all other persons using the Apple Mountain Golf Course, Clubhouse, driving range, golf carts and other amenities (collectively, "Facilities"), as well as any outside venue at which a Club event may be held. Apple Mountain and/or the Board may amend these Rules and Regulations at any time and from time to time.

## GENERAL RULES

1. Members and their guests shall abide by all rules and regulations of Apple Mountain and the Club as may be amended from time to time.
2. Apple Mountain shall be open on the days and during the hours as will be established by Apple Mountain from time to time. Areas of the golf course, driving range, and/or the portions of the Facilities may occasionally be closed due to weather, scheduled maintenance and repairs, or any other reason deemed appropriate by Apple Mountain. Apple Mountain reserves the right to close or restrict use of the Apple Mountain Facilities to hold promotional events and tournaments.
3. Tee times for Platinum and Gold members shall be restricted as follows:
  - a. June through September, Platinum and Gold members may schedule tee-times only before 9am and after 12pm on Saturdays, Sundays and Holidays. Tee times shall be accepted on a first-come, first-served basis by pre-registering with the appropriate Apple Mountain personnel or as directed by Apple Mountain.
  - b. January through May, and October through December, tee-times are on a first-come, first serve basis with the general public. Platinum and Gold Members are permitted to book tee times one day sooner than the general public.
4. Members are responsible for their own conduct and for the conduct of their guests. Any Member whose conduct or whose guest's conduct is deemed by Apple Mountain and/or the Board to be likely to endanger the welfare, safety, harmony or good reputation of Apple Mountain, the Club, or its guests or is otherwise improper, may be reprimanded, or have all golfing or Club tournament privileges suspended or terminated by Apple Mountain and/or the Board. Apple Mountain and the Board shall be the sole judges of what constitutes improper conduct, but improper conduct will include, without limitation: (i) failing to abide by the rules and regulations as set forth herein and as established by Apple Mountain and/or the Board from time to time, including but not limited to improper use of the driving range or failure to abide the Golf Car rules, (ii) mistreating Apple Mountain or Club personnel or employees, or (iii) acting in a manner incompatible with the established standard of conduct or which would likely injure the reputation of Apple Mountain and/or the Club. Apple Mountain and the Board shall be the sole judges as to the remedy for any improper conduct; provided however, that expulsion shall always be available to Apple Mountain and/or the Board for conduct in violation of the then current Rules and Regulations.
5. Apple Mountain reserves the right, in its sole discretion, to refuse service of Alcoholic beverages or any other item to a member or guest when that member or guest appears to be intoxicated.
6. Every Member of Apple Mountain and the Club shall be liable for any property damage caused by that Member or his guest(s). The cost of such damage shall be the responsibility of the Member.
7. Any complaints, criticisms or suggestions of any kind relating to any of the operations of Apple Mountain or its employees or to the operations of the Club should be addressed to the manager of Apple Mountain or to the Board, as appropriate.
8. Violation of any of these rules or conduct in a manner prejudicial to the best interests of Apple Mountain and/or the Club will subject the person in violation to disciplinary action by Apple Mountain and/or the Board in accordance with these Rules and Regulations, including without limitation, suspension or termination of all golf and/or Club tournament privileges, and expulsion from Apple Mountain and/or the Club.
9. The personnel of Apple Mountain and the Board will have full authority to enforce these Rules and Regulations and any infractions will be reported to the management of the Apple Mountain and the Board for disciplinary action, including without limitation, expulsion from Apple Mountain and/or the Club.
